The value of the non-life insurance market is shown in terms of gross premium incomes. Gross premium income is defined as the insurer's premium income for the year from its policies, calculated without reduction for reinsurance premiums paid or payable by the insurer.
- The Colombian non-life insurance market had a total gross-written premium total gross written premiums of \$6.6 billion in 2022, representing a compound annual growth rate (CAGR) of 6.7% between 2017 and 2022.
- The Motor segment accounted for market's the largest proportion in 2022, with total gross written premiums of \$2.6 billion, equivalent to 38.6% of the market's overall value.
- The Colombian economy faces substantial risks and trade-offs if inflation persists longer than anticipated, and customers' expenses increase in the future, which will also result in greater claim costs for non-life insurance companies.
