Summary

- The non-life insurance market consists of the general insurance market segmented into motor, property, liability and other insurance. The other segment is made up of non-life insurance products including health, travel, and accident cover among others. The value of the non-life insurance market is shown in terms of gross premium incomes. Gross premium income is defined as the insurer's premium income for the year from its policies, calculated without reduction for reinsurance premiums paid or payable by the insurer.
- The Japanese non-life insurance market had total gross written premiums of \$114.0 million in 2022, representing a compound annual growth rate (CAGR) of -0.4% between 2017 and 2022.
- The Motor segment accounted for market's the largest proportion in 2022, with total gross written premiums of \$51.4 million, equivalent to 45.1% of the market's overall value.
- Growth in the Japanese non-life insurance market was sluggish and volatile in the historic period 2017-22. The performance of the market is forecast to accelerate, with an anticipated CAGR of 6.3% for the five-year period 2022 2027, which is expected to drive the market to a value of \$154.5million by the end of 2027.
