The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2021 exchange rates.

- The Japanese fish & seafood market had total revenues of \$8,775.6m in 2021, representing a compound annual growth rate (CAGR) of 0.1% between 2016 and 2021.

- Market consumption volumes declined with a CAGR of -1.1% between 2016 and 2021, to reach a total of 1,142 million kilograms in 2021.

- The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.7% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$10,049.1m by the end of 2026.
