- The Japanese syrups & spreads market had total revenues of \$1,288.2m in 2021, representing a compound annual growth rate (CAGR) of 1.7% between 2016 and 2021.

- Market consumption volume increased with a CAGR of 0.3% between 2016 and 2021, to reach a total of 95.4 million kilograms in 2021.

- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.5% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$1,528.3m by the end of 2026.
