Summary

- The non-life insurance market consists of the general insurance market segmented into motor, property, liability and other insurance. The other segment is made up of non-life insurance products including health, travel, and accident cover among others. The value of the non-life insurance market is shown in terms of gross premium incomes. Gross premium income is defined as the insurer's premium income for the year from its policies, calculated without reduction for reinsurance premiums paid or payable by the insurer.
- The Kazakhstani non-life insurance market had total gross written premiums of \$1.1 million in 2022, representing a compound annual growth rate (CAGR) of 12.4% between 2017 and 2022.
- The property segment accounted for market's the largest proportion in 2022, with total gross written premiums of \$0.3 million, equivalent to 29% of the market's overall value.
- A positive growth trend in the volume of construction work is observed in 17 regions of the country, with the exception of the Mangystau, Abay, and Karaganda regions.
