The other segment is made up of non-life insurance products including health, travel, and accident cover among others. The value of the non-life insurance market is shown in terms of gross premium incomes. Gross premium income is defined as the insurer's premium income for the year from its policies, calculated without reduction for reinsurance premiums paid or payable by the insurer.
- The Malaysian non-life insurance market had total gross written premiums of \$5.4 million in 2022, representing a compound annual growth rate (CAGR) of 2.9% between 2017 and 2022.
- The Motor segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$2.4 million, equivalent to 44.2% of the market's overall value.
- The government is also taking various initiatives to boost e-commerce sales in the country, including the 'Go-eCommerce Onboarding campaign' to help SMEs to go online, providing them with financial aid and subsidies.
