The other segment is made up of non-life insurance products including health, travel, and accident cover among others. The value of the non-life insurance market is shown in terms of gross premium incomes. Gross premium income is defined as the insurer's premium income for the year from its policies, calculated without reduction for reinsurance premiums paid or payable by the insurer.
- The Pakistani non-life insurance market had total gross written premiums of \$0.9 million in 2022, representing a compound annual growth rate (CAGR) of 14.2% between 2017 and 2022.
- The Property segment accounted for market's the largest proportion in 2022, with total gross written premiums of \$0.5 million, equivalent to 55.7% of the market's overall value.
- The Pakistani non-life insurance market has experienced strong growth in recent years. The market grew at 7.0% in 2022, as compared to a high of 15.4% in 2021.
