- The South Korean pasta & noodles market had total revenues of \$2,603.2m in 2021, representing a compound annual growth rate (CAGR) of 5% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 3.7% between 2016 and 2021, to reach a total of 508.1 million kilograms in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 2.3% for the five-year period 2021 2026, which is expected to drive the market to a value of \$2,922.6m by the end of 2026.
