Household appliances includes major domestic appliances (air conditioners, dishwashers, dryers, freezers, hobs and extractors, microwave ovens, refrigerators, stoves, vacuum cleaners and washing machines) plus minor domestic appliances (blenders, coffee machines, deep fryers, food processors, grills, hair products, hair trimmers, curling tongs, razors, hand-held mixers, irons, juicers, kettles, stand mixers, toasters, sun lamps and fans). Photographic equipment includes camcorders, cameras, projectors, camera and camcorder accessories, binoculars and telescopes.
- The South Korean consumer electronics market had total revenues of \$42.8bn in 2021, representing a compound annual growth

rate (CAGR) of 4.1% between 2017 and 2021.

- The Household Appliances segment was the market's most lucrative in 2021, with total revenues of \$22.2bn, equivalent to 51.9% of the market's overall value.
- In 2020, the market recorded strong growth owing to impressive sales of premium home appliances, organic light-emitting diode (OLED) TVs, and vehicle component solutions.
