Gross premium income is defined as the insurer's premium income for the year from its policies, calculated without reduction for reinsurance premiums paid or payable by the insurer.

- The Czech non-life insurance market had total gross written premiums of \$6.4 billion in 2022, representing a compound annual growth rate (CAGR) of 8.2% between 2017 and 2022.

- The Motor segment accounted for market's the largest proportion in 2022, with total gross written premiums of \$1.7 billion, equivalent to 26% of the market's overall value.

- As a result of inflation driving up the costs of insurance clients in the Czech Republic, non-life insurance companies will experience an increase in the cost of claims.
