- The Polish hotels & motels industry had total revenues of \$1.9 billion in 2021, representing a negative compound annual rate of change (CARC) of 12.8% between 2016 and 2021.
- Industry consumption volume increased with a compound annual growth rate (CAGR) of 0.2% between 2016 and 2021, to reach a total of 2,489 establishments in 2021.
- The government of the country launched various campaigns to revive the country's tourism and hospitality industry. For instance, in November 2021, the Polish Tourism Organization (POT) launched a campaign "Poland. More than you expected" through social media channels to promote the country's tourism sector by highlighting the wealth and diversity of attractions across Poland.
