- Market consumption volume increased with a CAGR of 2.5% between 2016 and 2021, to reach a total of 523.2 million kilograms in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.5% for the five-year period 2021 2026, which is expected to drive the market to a value of \$5,309.7m by the end of 2026.
