- The Irish hotels & motels industry had total revenues of \$1.8 billion in 2021, representing a negative compound annual rate of change (CARC) of 14% between 2016 and 2021.
- Industry consumption volume increased with a compound annual growth rate (CAGR) of 0.8% between 2016 and 2021, to reach a total of 840 establishments in 2021.
- Ireland receives majority of the overseas trips from the US and mainland Europe. According to GlobalData, in 2020, the country received majority of the inbound arrivals from the UK (1.03 million), followed by 377.1 thousand from the US, 157.6 from Germany and 116.8 from France.
