- Market consumption volume increased with a CAGR of 1.1% between 2016 and 2021, to reach a total of 785.7 million kilograms in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 1.3% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$5,872.9m by the end of 2026.
