Summary

Key Highlights

- The value of the life insurance market is shown in terms of gross premium incomes from mortality protection and retirement savings plans.
- The Dutch life insurance market had total gross written premiums of \$13.9 billion in 2022, representing a compound annual growth rate (CAGR) of -3% between 2017 and 2022.
- The Life Insurance segment accounted for market's the largest proportion in 2022, with total gross written premiums of \$13.7 billion, equivalent to 98.5% of the market's overall value.
- The Pension/Annuity segment contributed gross written premiums of \$0.2 billion in 2022, equating to 1.5% of the market's aggregate value. The Dutch insurance market declined in 2022 but at a lower rate than in 2021. The market is expected to decline in 2023 as well but show a growth although at a slower pace during rest of the forecast period. The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.4% for the five-year period 2022 2027, which is expected to drive the market to a value of \$15.6billion by the end of 2027.
