- The non-life insurance market consists of the general insurance market segmented into motor, property, liability and other insurance. The other segment is made up of non-life insurance products including health, travel, and accident cover among others. The value of the non-life insurance market is shown in terms of gross premium incomes. Gross premium income is defined as the insurer's premium income for the year from its policies, calculated without reduction for reinsurance premiums paid or payable by the insurer.
- The Swiss non-life insurance market had total gross written premiums of \$34.9 billion in 2022, representing a compound annual growth rate (CAGR) of 3% between 2017 and 2022.
- The motor segment accounted for market's the largest proportion in 2022, with total gross written premiums of \$7.3 billion, equivalent to 20.9% of the market's overall value.
- According to European Automobile Manufacturers' Association (ACEA), the number of car registrations had increased to 21,406 units in November 2022 as compared to 18,825 units in November 2021.
