- The Turkish life insurance market declined drastically in 2022, however, it is still expected to continue to decline in 2023 but at a much lower rate. performance of the market is forecast to decelerate, with an anticipated CAGR of 2.5% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$1.8billion by the end of 2027.
