- The fish & seafood market consists of the retail sale of ambient fish & seafood, frozen fish & seafood, fresh fish & seafood (counter), chilled raw packaged fish & seafood processed, chilled raw packaged fish & seafood whole cuts and dried fish & seafood. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2021 exchange rates.
- The Turkish fish & seafood market had total revenues of \$599.4m in 2021, representing a compound annual growth rate (CAGR) of 12.2% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 1% between 2016 and 2021, to reach a total of 98.9 million kilograms in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 8.4% for the five-year period 2021 2026, which is expected to drive the market to a value of \$895.1m by the end of 2026.
