The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2021 exchange rates.
- The Turkish syrups & spreads market had total revenues of \$422.0m in 2021, representing a compound annual growth rate (CAGR) of 19.6% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 3.7% between 2016 and 2021, to reach a total of 87.5 million kilograms in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 28.5% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$1,477.3m by the end of 2026.
