- The European forest products market had total revenues of \$119.5 billion in 2022, representing a compound annual growth rate (CAGR) of -0.3% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 2.8% between 2017 and 2022, to reach a total of 965.3 million m3 in 2022.
- The value of the European forest products market grew by 7.3% in 2022, an improved performance as compared to 2021.
