- The North American life insurance market had total gross written premiums of \$708.8 billion in 2022, representing a compound annual growth rate (CAGR) of 2.7% between 2017 and 2022.

- The Pension/Annuity segment accounted for market's the largest proportion in 2022, with total gross written premiums of \$483.6 billion, equivalent to 68.2% of the market's overall value.

- Despite contracting by negative growth of 5.8% in 2019, the North American life insurance market experienced healthy growth in the historic period 2018 to 2022. According to the BLS (Bureau of Labour Statistics), 57% of employees in private industry had access to life insurance in March 2022. The performance of the market is forecast to accelerate, with an anticipated CAGR of 4.4% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$880.9billion by the end of 2027.
