- Online Specialists account for the largest proportion of sales in the Argentinian online retail market in 2021, sales through this channel generated \$6,308.0m, equivalent to 64.8% of the market's overall value.
- Consumers in Argentina rely on digital payment apps such as Modo or Mercado Pago to deposit money into their e-wallet to make purchases and to prevent the peso from losing its value quickly.
