- Online Specialists account for the largest proportion of sales in the Czech online retail market in 2021, sales through this channel generated \$6,418.3m, equivalent to 70.6% of the market's overall value.
- Virtual shopping is gaining traction in the Czech Republic with multiple firms attracting clients with cost saving benefits and home delivery options. Companies are offering several product categories from contact lenses to car tires.
