- The Greek online retail market had total revenues of \$3,841.6m in 2021, representing a compound annual growth rate (CAGR) of 15.9% between 2017 and 2021.
- Online Specialists account for the largest proportion of sales in the Greek online retail market in 2021, sales through this channel generated \$2,480.4m, equivalent to 64.6% of the market's overall value.
- In 2021, 79% of the population were internet users and 69% were e-shoppers according to Ecommerce Europe.
