Market Overview

The Mexico Automotive HVAC Market is consistently growing due to the rising requirement for automotive aftermarkets across the country. Furthermore, booming demand for thermal systems & climate control features in the automotive industry is likely to drive the country's market throughout the forecast year.

An automotive HVAC System is a mechanism dedicated to control heating, ventilation, and air conditioning inside an automotive vehicle's cockpit. The system regulates the temperature, humidity, and filtration in a vehicle's cabin using signals from sensors and microcontrollers in the case of the automatic system. It is also called as climate control as it manipulates or controls the climate inside an automotive vehicle.

The Mexico automotive HVAC market is expected to be driven by the rising requirement for automotive aftermarkets across Mexico and booming demand for thermal systems and climate control features in the automotive industry. However, the Mexico automotive HVAC market will likely be restrained by the decreasing automotive production across Mexico and the global shortage of semiconductors. On the other hand, the promising growth potential of the electric vehicle market is expected to create lucrative growth opportunities for players operating in the Mexico automotive HVAC market.

Market Segmentation

The Mexico Automotive HVAC Market has been segmented based on technology, component, vehicle type, and propulsion type. Based on technology, the Mexico Automotive HVAC Market has been segmented into Manual/Semi-Automatic and Automatic. The Automatic segment is estimated to grow at 6.33% during the forecast period, while in 2021, and it is accounted for 64.4% share. Based on component, the Mexico Automotive HVAC Market has been segmented into Evaporator, Compressors, Condensers, Receiver/Drier, and Expansion Devices. The Compressor segment is expected to grow at 4.8% during the forecast period and it is expected to hold 37.6% of the Mexico Automotive HVAC Market in the year 2021.

Based on vehicle type, the Mexico Automotive HVAC Market has been segmented into Passenger Cars, and Commercial Vehicle. The Commercial Vehicle segment is expected to grow at 6.3% during the forecast period and it is expected to hold 62.5% of the Mexico Automotive HVAC Market in year 2021.

Based on propulsion type, the Mexico Automotive HVAC Market has been segmented into ICE, and EV. The ICE segment is expected to grow at 5.7% during the forecast period and it is expected to hold 92.1% of the Mexico Automotive HVAC Market in year 2021.
