Inflation was a significant factor in Colombia in 2022, as in spite of higher oil prices, as a result of the Ukrainian war, which benefitted Colombian oil exports, other factors such as global supply constraints and currency depreciation led to higher prices. As a result, though baby and child-specific products registered a double digit increase in current value sales, constant value sales fell slightly, and volume growth was muted. A lowering birth rate also impacted volume sales.
