During 2022 inflation led to a trading down to mid and low priced brands. The market was also hindered by economic insecurity, high levels of poverty, crime and illicit trade, while widespread anti-smoking campaigns and tough legislation negatively impacted sales, despite the global renown of locally produced cigars. Nevertheless, legal sales of cigarettes benefited from a significant reduction in contraband due to improved surveillance measures at the country's borders.
