- The South African IT hardware market had total revenues of \$4.1 billion in 2022, representing a compound annual growth rate (CAGR) of 4% between 2017 and 2022.
- The client computing hardware segment accounted for the market's largest proportion in 2022, with total revenues of \$2 billion, equivalent to 49.2% of the market's overall value.
