- According to the Ministry of Commerce, in 2021, Chinese enterprises signed 6,257 new contracts for overseas engineering projects in 60 countries along the Belt and Road Initiative (BRI), with a new contract amounting to RMB864.7 billion (\$134 billion), sharing 51.9% of the amount of China's new contracts for overseas engineering projects in the same period.
