- The non-residential construction segment accounted for the industry's largest proportion in 2022, with total revenues of \$ 17.5 billion, equivalent to 85.4% of the industry's overall value.
- The Kazakhstani construction industry growth significantly declined in 2022, owing to the increasing inflation rate, rising geopolitical crises, rising energy cost and material costs, along with slow economic growth.
