- Industry production volume increased with a CAGR of 5.6% between 2017 and 2022, to reach a total of 107.8 thousand units in 2022.
- According to the Statistics Austria, in 2022, the registration of new passenger cars plummet by 10.3% over 2021. On the other hand, reduction in demand for new cars boosted demand for used cars because of their relatively less price.
