- The French advertising industry had total revenues of \$17,469.4 million in 2022, representing a compound annual growth rate (CAGR) of 3.5% between 2017 and 2022.
- The food, beverage & personal/healthcare segment accounted for the industry's largest proportion in 2022, with total revenues of \$5,477.6 million, equivalent to 31.4% of the industry's overall value.
- According to the National Institute of Statistics and Economic Studies (INSEE), in April 2023, consumer confidence in France exceeded market expectations by reaching a level of 83, up from a revised figure of 82 in the previous month.
