Summary

Mobile Phones in Germany industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-22, and forecast to 2027). Key Highlights

- The Mobile Phones market includes mobile phone service revenues and average minutes of use (MOU). Market values are made up of total mobile revenues containing revenues from mobile service providers and other members of the mobile service value-chain for the provision of mobile telephony services, excluding revenues from the sale of devices. Market volumes are made up of two segments: prepaid and postpaid, which consist of prepaid average monthly MOU and postpaid average monthly MOU. Minutes of use are made up from the average of voice minutes used in mobile subscriptions, including both incoming and outgoing calls, but not including M2M/IoT voice services.
- The German mobile phones market had total revenues of \$23.6 billion in 2022, representing a compound annual growth rate (CAGR) of 2.1% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 5.6% between 2017 and 2022, to reach a total of 432.4 average MOU in 2022.
- In 2022, the German mobile phones market witnessed a strong annual growth of 6.7%. The growth was driven by ongoing investments in 5G network expansion by operators and upgrading digital infrastructure in the country to improve fixed broadband connectivity.
