- The infrastructure services segment accounted for the industry's largest proportion in 2022, with total revenues of \$9.9 billion, equivalent to 59.3% of the industry's overall value.
- According to in-house research, the real GDP annual growth rate of the Netherlands stood at 4.4% in 2022.
