It consists of revenues gained by any advertising activities performed by the mean of Internet using mobile devices and personal computers. All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2022 annual average exchange rates.
- The Dutch digital advertising market had total revenues of \$3.4 billion in 2022, representing a compound annual growth rate (CAGR) of 12.1% between 2017 and 2022.
- The mobile segment accounted for market's the largest proportion in 2022, with total revenues of \$2.2 billion, equivalent to 63.3% of the market's overall value.
- The growing number of internet users has propelled investments in digital advertising. According to in-house research, in 2022, the number of internet users in Netherlands reached 16.4 million.
