- The food, beverage & personal/healthcare segment accounted for the industry's largest proportion in 2022, with total revenues of \$2,767.7 million, equivalent to 22.3% of the industry's overall value.
- The real GDP annual growth rate of Spain in 2022 stood at 4.5%, according to in-house research.
