All market data and forecasts are represented in nominal terms (i.e. without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2022 annual average exchange rates.
- The UK advertising industry had total revenues of \$43,014.9 million in 2022, representing a compound annual growth rate (CAGR) of 8.4% between 2017 and 2022.
- The retailer segment accounted for the industry's largest proportion in 2022, with total revenues of \$9,485.2 million, equivalent to 22.1% of the industry's overall value.
- In April 2023, the GfK Consumer Confidence indicator in the UK increased to -30 from -36 in March, reaching its highest level since February 2022.
