- The UK casinos & gaming sector had a total gross gaming win of \$10 billion in 2022, representing a negative compound annual growth rate (CAGR) of 3.7% between 2017 and 2022.
- The lotteries segment accounted for the sector's largest proportion in 2022, with total gross gaming wins of \$5.3 billion, equivalent to 52.4% of the sector's overall value.
- In the UK's casinos & gaming sector, the Gross Gambling Yield (GGY) is a critical performance indicator that measures the total amount of revenue earned by the sector. According to the Gambling Commission in the UK, the total gross gambling yield (GGY) of the Great Britain gambling industry stood at GBP14 billion (\$19.3 billion) from 2021 to 2022.
