- According to the Central Bureau of Statistics in Israel, the GDP from construction in Israel increased to ILS20,482.5 million (\$6,094.95 million) in the third quarter of 2022 from ILS19,297.4 million (\$5,742.30 million) in the previous quarter of 2022.
