- Market volume increased with a CAGR of 0.6% between 2017 and 2022, to reach a total of 10.7 million subscribers in 2022.
- The Israel's share of the wireless telecommunication services market around the Middle East stood at 8.3% in 2022. The market growth is attributed to the increasing proportion of internet users and the ratio of mobile to fixed lines. For instance, according to in-house research, in 2022, the proportion of internet users in the total population of Israel reached 93.8%.
