- The Turkish advertising industry had total revenues of \$2,095.8 million in 2022, representing a compound annual growth rate (CAGR) of 31.9% between 2017 and 2022.
- The media & telecommunication segment accounted for the industry's largest proportion in 2022, with total revenues of \$212.4 million, equivalent to 10.1% of the industry's overall value.
- Turkey's increasing GDP per capita has expanded consumer confidence. According to in-house research, the GDP annual growth rate in Turkey averaged 4.81% from 1999 until 2022, reaching 11.6% in 2021.
