- According to the Turkish banking sector regulator, BDDK (Bankacilik Duzenleme ve Denetleme Kurumu), Turkish banks' loan interest income increased by 82% to \$80.97 billion, while lenders' net interest income increased by 196% to \$73.90 billion.
