- The Turkish digital advertising market had total revenues of \$1.2 billion in 2022, representing a compound annual growth rate (CAGR) of 55.3% between 2017 and 2022.
- The Mobile segment accounted for market's the largest proportion in 2022, with total revenues of \$0.9 billion, equivalent to 74.3% of the market's overall value.
- According to in-house research, Turkey held a 1.2% stake in 2022 in the global digital advertising market and is witnessing continuous growth.
