- The infrastructure construction segment accounted for sector's the largest proportion in 2022, with total revenues of \$540.9 billion, equivalent to 33.1% of the sector's overall value.
- According to the European Construction Industry Federation (FIEC) report, out of the major construction projects for 2021, non-residential construction (offices, hospitals, hotels, schools, and industrial buildings) accounted for 31.3% of all activity.
