In 2022, there was a significant fall in volume sales. Authorities in Kazakhstan have been implementing tough anti-tobacco policies and these are bearing fruit, with smoking prevalence falling in 2022. A further rise in excise duty was another incentive to stop smoking. Some people are giving up smoking completely and others are switching to e-vapour products in particular, which are perceived as less harmful to health. This shift was also boosted by increased availability of e-vapour products.
