Inflation was a key issue for most products in Chile during 2022. With 30-year high rates, unit prices significantly increased, with this impacting some categories of alcoholic drinks more than others and therefore demand. For RTDs, inflation had a stronger impact in terms of unit prices compared to the overall local industry (a 17% rise in total value RSP compared to 15%). This negatively impacted demand for RTDs in 2022, with the category experiencing a marginal drop in total volume terms. Whi...
