The media industry within the NAFTA countries had a total market value of \$460.0 billion in 2021. The US was the fastest growing country, with a CAGR of -0.3% over the 2017-21 period.
- Within the media industry, the US is the leading country among the NAFTA bloc, with market revenues of \$435.0 billion in 2021. This was followed by Canada and Mexico, with a value of \$16.3 and \$8.6 billion, respectively.
- The US is expected to lead the media industry in the NAFTA bloc, with a value of \$501.3 billion in 2026, followed by Canada and Mexico with expected values of \$18.6 and \$10.5 billion, respectively.
