- The G8 countries contributed \$2,861.9 billion in 2022 to the global non-life insurance industry, with a compound annual growth rate (CAGR) of 5.1% between 2018 and 2022. The G8 countries are expected to reach a value of \$3,550.4 billion in 2027, with a CAGR of 4.4% over the 2022-27 period.
- Among the G8 nations, the US is the leading country in the non-life insurance industry, with market revenues of \$2,170.3 billion in 2022. This was followed by Germany and the UK, with a value of \$174.6 and \$122.7 billion, respectively.
- The US is expected to lead the non-life insurance industry in the G8 nations with a value of \$2,642.0 billion in 2016, followed by Germany and Japan with expected values of \$248.9 and \$154.5 billion, respectively.
