- These countries contributed \$428.6 billion to the global non-life insurance industry in 2022, with a compound annual growth rate (CAGR) of 6.1% between 2007 and 2011. The top 5 emerging countries are expected to reach a value of \$603.1 billion in 2027, with a CAGR of 7.1% over the 2022-27 period.
- Within the non-life insurance industry, China is the leading country among the top 5 emerging nations, with market revenues of \$338.3 billion in 2022. This was followed by India and Brazil with a value of \$32.4 and \$30.0 billion, respectively.
- China is expected to lead the non-life insurance industry in the top five emerging nations, with a value of \$473.9 billion in 2027, followed by Brazil and India with expected values of \$46.1 and \$44.1 billion, respectively.
