The meat industry within the NAFTA countries had a total market value of \$241,187.1 million in 2021. The Mexico was the fastest growing country, with a CAGR of 4.1% over the 2017-21 period.
- Within the meat industry, the US is the leading country among the NAFTA bloc, with market revenues of \$193,366.2 million in 2021. This was followed by Mexico and Canada, with a value of \$27,826.4 and \$19,994.4 million, respectively.
- The US is expected to lead the meat industry in the NAFTA bloc, with a value of \$216,721.3 million in 2026, followed by Mexico and Canada with expected values of \$33,752.4 and \$24,264.4 million, respectively.
